## DIRECTIONS FOR USE

**MIXING:** Fill spray tank ½ full, add the desired amount of herbicides and continue filling. Add the **KAMMO™** last. After filling continue agitation.

**AIR APPLICATION:** 2-8 pints in 2-15 gallons of water. Do not exceed 10% concentration by volume.

**GROUND APPLICATION:** 2-8 pints in 15-100 gallons of water. Do not exceed 10% concentration by volume.

### RIGHTS-OF-WAY, FORESTRY, INDUSTRIAL AND RAILROADS:

Foliar—2 qts. to 1 gal. per acre.

Dormant—1 to 2 gallons per acre.

### AQUATICS:

Surface—1 to 2 quarts per acre.

Submerged—1 or 2 gallons per acre.
