NALCOTROL® DIRECTIONS FOR USE

IMPORTANT: Always shake the NALCOTROL® container well before use. Never add water to the NALCOTROL® container.

Use NALCOTROL® with Roundup and Accelerate. Use NALCOTROL® with all other pesticide.

STEP 1. Select correct NALCOTROL® dosage from chart below.

STEP 2. Always add Roundup or Accelerate to the mix tank before NALCOTROL®.

The measured amount of NALCOTROL® should be added as a pencil-thin stream to the agitating mix tank or for tanks with weak agitation, to the surface agitation created during the tank filling operation.

STEP 3. If additional spray adjuvants are used, they should be added last (after NALCOTROL®).

STEP 4. Continue to agitate the mix tank before use.
